A “COST SAVINGS” MEASURE FOR THE TOWN

- The change from quarterly Real Estate & Personal Property tax bill mailings to semi-annual was implemented as a cost savings measure due to budget cuts in Fiscal Year 2010
- Realized savings of \$11,000 in tax bill printing and postage expenses

Residents now receive only 2 Real Estate & Personal Property tax bill mailings per fiscal year (July 1 to June 30), as follows:

- **“Preliminary” Tax Bills** are mailed just before July 1 and include 2 remittances and 2 return envelopes for the 1st and 2nd quarters:
- 1st Quarter bills due August 1
- 2nd Quarter bills due November 1

- “Actual” Tax Bills are mailed just before January 1 and include 2 remittances and 2 return envelopes for the 3rd and 4th quarters:
- 3rd Quarter bills due February 1
- 4th Quarter bills due May 1

Note: the Town’s Fiscal Year runs from July 1 to June 30
