Measure 2025-013- Approval of Proposed Amendment to the Naming of Assets Bylaw that was adopted on June 7, 2023.

Purpose and Justification:

The Town Council adopted Chapter 195 Naming of Town Assets Bylaw on June 7, 2023 (Measure 2023-010). The Bylaw has been invoked twice since adoption and there are some areas that have caused confusion. This measure proposes to clarify the language of the Bylaw and streamline the process.

The Town Council met on September 23, 2024, and on behalf of the Town Council, a motion was made by Vice-President Simmons to refer Measure 2025-013- Approval of Proposed Amendment to the Naming of Assets Bylaw that was adopted on June 7, 2023 to the Bylaw Sub-Committee for further review and consideration.

The motion was seconded by Councilor Donovan.

Motion carried. 5-0

The Bylaw Sub-Committee met on September 25, 2024, and on behalf of the Committee, a motion was made by Councilor Donovan to refer Measure 2025-013- Approval of Proposed Amendment to the Naming of Assets Bylaw that was adopted on June 7, 2023 back to the Full Town Council with a positive recommendation.

Motion was seconded.

Motion carried.

The Town Council met on October 16, 2024, and on behalf of the Town Council, Councilor Shanahan reported on Measure 2025-013- Approval of Proposed Amendment to the Naming of Assets Bylaw that was adopted on June 7, 2023.

The Town Council met on October 28, 2024, and on behalf of the Town Council, Vice-President Simmons made a motion to waive the First Reading of Measure 2025-013- Approval of Proposed Amendment to the Naming of Assets Bylaw that was adopted on June 7, 2023.

Councilor St. Pierre seconded the motion.

Motion carried 9-0.

The Town Council met on November 13, 2024, and a Public Meeting was held on this measure and on behalf of the Town Council, a motion was made by Vice-President Simmons to waive the Second Reading and approve Measure 2025-013- Approval of Proposed Amendment to the Naming of Assets Bylaw that was adopted on June 7, 2023. This Bylaw will sit for 21 days and will then be passed.

The motion was seconded by Councilor Donovan.

Motion carried. 8-0 UNANIMOUS
